

Men's Monday Night League 2021

Monday, June 7 First Night of League; Divisions Based on 5:30 or 6:00 shotgun
Monday, June 14

First place team plays second place team - 3 plays 4 etc.

***POLICY:** Each individual player can miss up to **3** league nights with **NO PENALTY**.
But, if a player misses 4+ weeks of play, then his team cannot finish in the money.
One team member must be present each week of league (cannot have 2 subs on a team)
Matches can be made up in advance of league night.
Each player/team is responsible for finding a sub. (any WLGC member can be a sub)

FORMAT:

2 Divisions (12 Teams per division)

Each year we will name our divisions - Division 1 = Barry & Division 2 = Bitter

MAXIMUM Handicap is 18.

Players will play off the Low handicap players handicap -

Example: Don is a 2 and Frank is a 5, Don plays to a zero and Frank plays to a 3 hdcp.

Player A Team 1 vs. Player A Team 2: Hole-by-Hole Match-Play. 1 point per Hole WON, .5 point for TIE.

Player B Team 1 vs. Player B Team 2: Hole-by-Hole Match-Play. 1 point per Hole WON, .5 point for TIE.

Each Player Match-up has 10 points Available!

1 point per Hole, and 1 point for the Player won the MOST points; .5 points each, if you TIE.

20 points TOTAL per night!
