## MONTHLY DUES PAYMENT OPTION NOW AVAILABLE

We are excited to inform you that being a member at White Lake Golf Club is easier than ever. Starting in January 2017, members will have the option to pay the annual dues and optional add-on expenses monthly, over 12 months, using a credit/debit card on file. **Following is an example of how this will work:**

WLGC utilizes a Point of Sale system that has state of the art security and encrypts credit card numbers that would be kept on file. As an additional benefit, when signing up for this program, it will also allow members to “charge to account” all purchases made during the golf season for merchandise, cart rentals, guest fees, etc. Members will be billed at the end of each month for any additional purchases made.

If you are interested in taking advantage of this program, it will start in January and you need to complete and return the authorization form below and return by January 15, 2017. **A worksheet for you to complete** and select add-on expenses is also included (This program is not available for Seasonal/Student Memberships).
